TERMS AND CONDITIONS FOR ENGAGEMENT OF HEALTH EXPERT IN OMBADC.

i. Educational Qualifications

Master's Degree in Public Health/ Community Health/ Preventive & Social Medicine from a recognized university/ academic institution.

Excellent working knowledge in MS Office and outstanding written and oral skills in both English and Odia.

ii. Age Limit:

The candidate should not be more than 45 years of age as on 01.01.2023

iii. Post Qualification Experience

Minimum 8 to 10 years' working experience in managing health related projects in private/ Public organizations of repute.
